## **Background**

As part of its canonical responsibilities, Mercy Partners ensures that the Ministries operate within the teachings and laws of the Catholic Church. This involves:

- Establishing and approving the Ministry Boards Formation for Mission Policy and Framework.
- Coordinating the delivery of at least one annual Catholic Identity session for Ministry Boards.
- Facilitating and delivering Formation Induction programs for Ministry Boards and key Ministry leaders.

## Induction

Mercy Partners leads the Induction (Civil and Formation Governance) for our Mercy Partners Ministries. This entails:

- Induction for all new Ministry directors, CEOs/Principals and Mission Leaders
- Induction for new Ministry Boards.
- An Induction refresher every three years for all Ministry Boards.

## **Mission Leaders**

Mercy Partners supports Ministry Mission Leaders through its annual gathering, providing networking opportunities, sharing information about external formation experiences, and offering access to Mercy Partners resources.

For ministries without a dedicated Mission Leader, Mercy Partners provides support with formation planning and delivery, if required.
